

Summary

- In the latest release we've added a new Generic Connector's service, the benefits that this brings, is that for users who have over 1000 source assets like google drive Shares or Sites under a single account, we have added a new Folder navigation to simplify the process for customers with big number of source assets.
- In this release the team have also made many incremental improvements to our new Forcepoint DSPM product.
- Some highlights of this release include a new Folder Selector Component which replaces the old Tree View for folders.
- Also, a new Explore Trustees page, replacing the Company Overview page. This is now a single place to search for users in AWS, Google, Azure, and other sources. See below.

- We've added the ability to read AIP labels and display on our UI and created a new risk algorithm for SharePoint files. This new risk algorithm has improved how we calculate the risks of the data stored in SharePoint. For example, if a file is critical and shared with 3rd parties we will flag such files.
- Also out in this release is an enhancement request for representing externally shared data.
- In addition to this, the team have fixed a number of known issues and bugs around Data Control, Data Assets, and the Compliance Hub.

New Features

- New Folder Selector Component replaces the old Tree View folders
- New Explore Trustees page - replacing Company Overview page
- New Generic Connectors service
- AIP Labels - Ability to read AIP labels and display on our UI
- Externally shared: An enhancement request for representing externally shared data.
- Creation of a risk algorithm for SharePoint files

- Column Names on the Data Assets tables - Adding Tooltips for better UX
- Added filters to Data Assets inventory
- Added new symbols for quoting in GQL
- New GQL filters for Data Owner and Data Attribute
- Removal of invalid taxonomy screen

Resolved Issues

- Admin filter is not working for trustees
- Data Control Ownership field shrinking issue
- Data Assets: Inconsistent sizes in departments drop-down component
- Compliance Hub - Departments: Missing validation for email addresses
- Compliance Hub - Missing required label for specific groups
- Folder Selector: confluence_cloud is showing incorrect path
- Long list of permissions is getting truncated in permissions dialog box
- Explore: missing sorting feature for the table's columns
- Detectors: Valid regex causes internal service error
- Fix p-dropdown selected item redraw issue
